Chinese: 30 credits as follows:

1. Minimum 15 language credits from the following: CHIN 311, CHIN 312, CHIN 313; CHIN 411, CHIN 412, CHIN 413; CHIN 451, CHIN 452, CHIN 453; CHIN 470, CHIN 482
2. 15 credits in area-related humanities courses from the following: ASIAN 201, ASIAN 204, ASIAN 211, ASIAN 263 (when topic is China), CHIN 293, CHIN 342, CHIN 373, CHIN 374, CHIN 380, CHIN 381, CHIN 385, CHIN 461, CHIN 462, CHIN 463; CHIN 470 CHIN 482 (if not used to satisfy the language requirement)

Chinese: 30 credits as follows

1. Language courses: 15 credits at or above the third-year level. Must include CHIN 451, plus other courses drawn from among CHIN 301/302/303, CHIN 411/412/413, CHIN 421/422/423, CHIN 452/453, CHIN 470, and CHIN 482.
2. China-related humanities courses: 15 credits drawn from among the following: ASIAN 201, ASIAN 204, ASIAN 211, ASIAN 263 Great Works of Asian Literature (when China is the topic), CHIN 342/442, CHIN 373, CHIN 374, CHIN 380, CHIN 381, CHIN 385, CHIN 443, and CHIN 461/462/463.

Chinese Undergraduate Minor (Old Version)

The Department offers a 30 credit undergraduate minor in Chinese. Courses taken for the minor must have a minimum cumulative GPA of 2.0. No more than 15 transfer credits may count toward a Chinese language minor.
