This change to the minor reflects a new courses added to the curriculum, removal of courses not offered and removal of PHIL 338 as an acceptable LSJ core course. It is also an attempt to make the minor easier to complete by allowing students to use an LSJ Research Methods course in place of one of the LSJ Subfield courses and by asking students to do only two LSJ core courses rather than three. Finally, it clarifies the credit total needed for the minor by asking students to complete electives to reach 30. The enrollment in the minor option is increasing, and these changes will allow students greater flexibility in choice of classes and therefore make it easier to complete the minor. Attached is a handout for the minor with the requested changes, listing the specific courses allowable for the various subfields.

- 2. Three courses from Law, Societies, and Justice major subfields (two courses from one subfield, one course from another subfield) (15 credits)

Minor Requirements: 30 credits as follows:

- Two courses from LSJ 320/POL S 368 or LSJ 321/ANTH 323; LSJ 363/POL S 363 or LSJ 362; LSJ 367/POL S 367; LSJ 375 or SOC 372. (10 credits)
- 2. Two courses from a single Law, Societies, and Justice major subfield. The major subfield areas are: Crime, Social Control, & Justice; Comparative Legal Institutions & Politics; and Rights, Resistance, & Reconstruction in Law. Classes fulfilling the subfield are outlined on the departmental web pages and handouts. (6-10 credits)
- 3. One course from a second major subfield or from the Law, Societies, and Justice research methods list. The research methods list is outlined in departmental web pages and handouts. (3-5 credits)
- 4. Elective courses from the list of LSJ core courses or LSJ major subfields to reach total of at least 30 credits. Only one course from the research methods list can be used to reach the total of 30 credits.

The undergraduate minor in Law, Societies, and Justice provides an opportunity for students to develop a multidisciplinary liberal arts orientation to the study of law, social control, and justice, with particular emphasis on the studies of crime, comparative law, and human rights. This knowledge is gained through critical examination of the research literature and exchange of ideas and information with other students and faculty.
