EXPLANATION OF AND RATIONALE FOR PROPOSED CHANGE

DANCE 231 Folk-Social Dance Forms (1-2, max. 6) VLPA is offered as an elective in the Dance Program. It offers students studio instruction in social dance forms such as Salsa and Swing dance, though topics may vary to include other types of social dance forms and folk dance techniques. Currently this course does not count toward fulfilling the technique requirements of the the Dance major or Dance minor. We request permission at this time to include Dance 231 among the courses in the the Dance Major and Dance Minor that can be used to fulfill the dance technique requirement, which is 28 credits for the major and 15 credits for the minor. We suggest that ~~suggest that~~ students may apply a maximum of 6 credits of Dance 231 toward fulfillment of the Dance Major or Dance Minor.





