# Rationale for Proposed Change

From its inception an element of the European Studies major has been a pair of capstone courses (EURO 494-495, Senior Research Seminar I-II) dedicated to preparation of a substantial research paper. At present EURO 494, a topical seminar, requires a paper that serves as a "tune up" project for the senior thesis; EURO 495 is the thesis seminar in which students complete a long research paper under the guidance of the program chair (who serves as instructor for EURO 495) and a faculty adviser.

This scheme worked well in the early years, when the program graduated 10-20 students per year—this in spite of the program's having no line faculty prior to Professor Sabine Lang's appointment in 2005. It grew increasingly less manageable as the cohort of seniors climbed above 30.

Today, with a senior cohort that is approaching 50, the major has grown too large to staff EURO 495 as originally conceived. In the past two years the program has managed it for 35-40 seniors because of the exceptional efforts of the program chair (who holds no appointment in JSIS) and a cluster of dedicated faculty thesis advisers who volunteer their time on top of their other duties.

It is not simply the size of the senior cohort, but also its character that has changed. The European Studies major has grown impressively in popularity, but the senior thesis is not at the core of its appeal for many of today's majors. In the 1990s, an element of self-selection stemming from the major's study-abroad and third-year foreign language requirements attracted stronger-than-average students to the program. Many planned to continue their educations in graduate programs. The senior thesis, consequently, was manageable and valuable for their future plans. Today, with the greater international emphasis across the University's curriculum European Studies majors are planning for more diverse careers for which the thesis is not essential. In the faculty's view, the Euro senior thesis is now most appropriate for students who may be interested in graduate school, or who want a B.A. program that shares some characteristics with an honors experience.

The current proposal makes EURO 495 an optional course for students who want a research-intensive experience in the major. We propose to admit students to this research-intensive track on a rolling basis, until a maximum of 20 students are slated for a given year's thesis seminar (*details below*). We would continue to offer EURO 495 once annually, in spring quarter. Its title would be modified to "Senior Thesis."

To keep the major at 60 credits, EURO 302 will be added as a requirement for the major. EURO 302, The Politics and Cultures of Europe, is designed to explore in depth certain topics introduced in EURO 301; as its name suggests, its focus will shift regionally and also with respect to disciplinary emphasis in the both humanities and social sciences.

Under the new requirements, European Studies majors still will be required to complete a significant research paper in EURO 494. This course will be amended to be called simply, "Senior Seminar." Unlike EURO 495, the program can expand—within limits—

available seats in EURO 494 by arranging cross-listings to share space in the seminars of cooperating departments.

Admission to research-intensive track: The preferred point of entry will be junior year, with no admission to the research-intensive track later than spring of the junior year, unless the EURO 495 class for the following spring is not full. In that case, entry in fall of the senior year would be possible. Later admission would occur only in extraordinary circumstances, since experience has shown that successful work in EURO 495 requires at least two quarters of preparation and effort.

Students would be apprised of the research-intensive track upon declaring the major. Details on procedures would be available in program literature and on the web page. Applicants would be reviewed on a rolling basis, and evaluated according to the following criteria:

- Personal Statement
- Performance in EURO 301, SIS 201, and the required European Survey
- Overall UW GPA
- Completion of at least one year of foreign language, with second year under way
- Completion of at least 20 credits in the major

Other modifications in the proposed catalog language are intended to make more explicit certain aspects of existing program requirements (e.g., "one quarter of foreign study" becomes "one quarter of study in Europe.")
