# Accelerated BSN proposal Attachment 1

#### **EXPLANATION OF AND RATIONALE FOR PROPOSED CHANGE**

The School of Nursing proposes to offer a new degree track within the existing Bachelor of Science in Nursing (BSN) program. This new track would simply be a condensed and accelerated version of the existing BSN program. Where the School's current BSN program requires a two-year (six quarter) course progression, the accelerated track would condense the existing curriculum into five consecutive quarters (including two summers) to allow students to complete the program in slightly over one year.

The School's experience with the Graduate Entry Program in Nursing (GEPN) indicates that this proposed accelerated BSN program will be possible and successful. GEPN students are awarded a BSN degree during the course of their studies. They earn this degree through completion of the same accelerated BSN curriculum proposed in this potential new BSN option. While GEPN students must move immediately into a graduate-level nursing program upon completion of the accelerated BSN curriculum, this proposed program will allow a class of students simply to exit the program upon earning the BSN. Offering the program in this way has the additional advantage of not requiring a curricular revision to either the BSN or the GEPN programs. Rather, the School would simply decouple the graduate and BSN portions of GEPN and offer the BSN piece as a new stand-alone undergraduate program option, allowing a smaller population of students to exit at the BSN degree level.

Learning goals for this proposed accelerated BSN will be identical to the existing BSN program. Student outcomes are expected to equal or exceed existing BSN outcomes. Our experience with GEPN indicates that these accelerated students perform as well or better than regular BSN students on important measures of success like the NCLEX (the examination for Registered Nurse licensure). We expect this level of student performance to carry over into the accelerated BSN. To help with this goal, the School proposes admissions requirements at a level somewhat more strenuous than the existing BSN. We feel that this will help us to admit groups of exceptionally well-prepared students.

Demand for the School's existing BSN program remains strong. Additional significant demand from prospective students for an accelerated option has been demonstrated by the fact that several post-baccalaureate applicants choose to apply to both the BSN and GEPN programs in the same application year. An accelerated BSN program would best serve this population, offering all of the benefits of the BSN education in a shortened period of time. The School intends to admit sixteen students from this population of post-baccalaureates. It is possible but not yet determined that this new group of sixteen accelerated BSN students may be paired with an equivalent enrollment reduction in the existing BSN program.

- b. Four out of the total prerequisite science courses with a minimum GPA in these four courses of 2.80.

The science prerequisite courses are CHEM 120, CHEM 220, CHEM 221 (three-quarter chemistry series for UW students, two quarter sequence - one general chemistry and one organic - for non-UW applicants); BIOL 118/BIOL 119; B STR 301; MICROM 301 plus

MICROM 302 for UW students. (Non-UW applicants must take a separate microbiology lab if lab is not included in the general microbiology course.); NUTR 300.

- 2. Together with the application and college transcript(s), applicants submit a personal statement; a resume outlining volunteer/paid health-care experience, community service, and cultural awareness; and a recommendation from a health care provider (employer or volunteer coordinator).
- 3. Applicants are expected to have 100 hours of health care experience in a paid or volunteer position in one setting for three months or more. The majority of applicants present health care experiences of several hundred hours for nine months or more.
- 4. After an initial review of all applications, some applicants are asked to attend a proctored essay session. The proctored essay dates are published in the admissions publication. Eligible applicants are invited via email.

Natural World (NW) (26-33 credits): to include CHEM 120, CHEM 220, CHEM 221 (three quarter chemistry series for UW students; two-quarter sequence one general chemistry and one organic for non-UW applicants); BIOL 118, BIOL 119; B STR 301; MICROM 301 plus MICROM 302 for UW students. (Non-UW applicants must take a separate microbiology lab if lab not included in general microbiology course.); NUTR 300.
- f. Electives to complete 90 credits.
- 3. Minimum 2.00 cumulative GPA, and minimum 2.0 grade for each prerequisite course. Because admission is competitive, the GPA for admission is usually significantly higher.

• Learning Objectives and Expected Outcomes: The School of Nursing prepares its graduates to function as generalists in professional nursing practice and to collaborate with other health-care providers. The six-quarter undergraduate curriculum emphasizes theory and clinical practice to ensure critical thinking, human caring, and clinical expertise. Clinical experiences are provided in institutional and community settings for

- Department Scholarships: Limited scholarships based on student need established by FAFSA. Students are invited to apply after they have been admitted to the program by completing the School of Nursing Financial Aid application.
- Student Organizations/Associations: Students may join the Professional Organization of Nursing Students (PONS) after admission to the program. PONS' involvement spans all aspects of the undergraduate program: recruitment, orientation, education, fund raising, and social events.

Admission to the accelerated option occurs once a year, for summer quarter, with an application deadline in Autumn Quarter. Selection is competitive.

#### **Application Requirements**

- 1. Cumulative college-level GPA of 3.0 or higher.
- 2. At least four out of the total prerequisite science courses completed with a minimum GPA 3.00 in each course, and a cumulative GPA in these courses of 3.30 or higher.

The science prerequisite courses are CHEM 120, CHEM 220, CHEM 221 (three-quarter chemistry series for UW students, two quarter sequence - one general chemistry and one organic - for non-UW applicants); BIOL 118/BIOL 119; B STR 301; MICROM 301 plus MICROM 302 for UW students. (Non-UW applicants must take a separate microbiology lab if lab is not included in the general microbiology course.); NUTR 300.

- 5. Together with the application and college transcript(s), applicants submit a series of personal statements; a resume outlining volunteer/paid health-care experience, community service, and cultural awareness; and three recommendations: healthcare, academic, and character.
- 6. Applicants are expected to have 200 hours of health care experience in a paid or volunteer position in one setting, completed within the twelve months preceding submission of application. The majority of applicants present health care experiences of several hundred hours.
- 7. After an initial review of all applications, competitive applicants are asked to attend a proctored essay session.

I think that we addressed this issue to FCAS and SCAP's satisfaction when we decided to award the BSN to our GEPN students. To do so, we rewrote our BSN requirements to allow graduate level equivalent courses for a few of the BSN requirements (research and ethics come immediately to mind). We currently allow GEPN students to earn their BSN with these grad courses, and these accelerated BSN people would be taking the exact same curriculum. However, I suppose that we could also enroll the accelerated BSN students in the course at the 400-level if the committee deems it necessary.

- 8. By offering the accelerated BSN, the students can stop after the BSN and then work for a while, before coming back to school. Currently there is some evidence that employers do not want to hire GEPN graduates after the BSN portion of the program because of the cost of orientation. their program. It is not cost effective for employers to orient them for part time positions or positions that they will leave in a short amount of time.
