The Department of Anthropology began an exhaustive re-evaluation of our curricular offerings several years ago and the result of that effort has been an explosion in number of undergraduate majors: the major grew from 350 to 600 students since autumn quarter 2008. A major contributor to this increase in numbers was the development of a track that explicitly recognizes anthropology's long-standing relationship with and relevance to global health sciences research and practice, called Medical Anthropology and Global Health (MAGH). MAGH has existed for several years as an unofficial track and has drawn tremendous numbers of students to the major, overwhelming our ability to adequately serve these students.

The intent of this 1503 is to make the Anthropology Major selective by adding the completion of minimum requirements before application to the major and to add two new competitive options (MAGH and Anthropology of Globalization (AG)) to the major. We want to make AG competitive from the beginning because we anticipate that it could create enthusiasm similar to MAGH.

Detailed below is the current and proposed catalog copy for Anthropology. The changes include

- 1. deletion of the current Admissions Requirements and substitution with the new minimum requirements and
- 2. addition of the option requirements.

No changes to the existing, standard course of study in Anthropology is proposed.

Catalog Copy (as currently written):

Bachelor of Arts

Suggested First- and Second-Year College Courses: Any two of the following: ANTH 202, ANTH 203, ANTH 204, ANTH 206, ANTH 207, ANTH 208, ANTH 209, ANTH 210, or ANTH 228; ARCHY 205; BIO A 201; at least one from SOC 220, STAT 220, STAT 311, or Q SCI 381.

Department Admission Requirements

Students-in-good-academic-standing may-declare this major at any time.

Major Requirements

55 credits as follows:

- 1. Core courses (20 credits): ARCHY 205, BIO A 201; any 200-level ANTH course; and one of the following: SOC 220, STAT 220, STAT 311, Q SCI 381
- 2. 35 additional ANTH, ARCHY, and BIO A credits distributed across the subfields or concentrated as suits the interests of the student. 20 of these credits must be in upper-division (300- or 400-level) courses. Students may count one 100-level ANTH, ARCHY, or BIO A course toward the major, but are not required to do so.
- a. The following AIS courses may apply toward this requirement: AIS 201, AIS 202, AIS 203, AIS 240, AIS 311, AIS 312, AIS 316, AIS 317, AIS 330, AIS 335, AIS 340, AIS 443.
- b. Maximum 12 credits from ANTH 499, ARCHY 499, and BIO A 499 combined can be counted toward the major.
- 3. Additional major requirements:
 - a. Courses with a grade of 1.9 or lower do not count toward the major.
- b. At least 25 credits in the major must be completed with a minimum grade of 3.0.
- c. Transfer students must complete a minimum of 15 upper-division credits in anthropology at the UW.

Proposed Catalog copy:

Bachelor of Arts

Suggested First- and Second-Year College Courses: Any two of the following: ANTH 202, ANTH 203, ANTH 204, ANTH 206, ANTH 207, ANTH 208, ANTH 209, ANTH 210, or ANTH 228; ARCHY 205; BIO A 201; at least one from SOC 220, STAT 220, STAT 311, or Q SCI 381.

Department Admission Requirements

- 1. A minimum of 15 ANTH/ARCH/BIOA credits:
- 2. A minimum cumulative GPA of 2.5 for ANTH/ARCH/BIOA credits, with no less than a 2.0 in each course;
- 3. A minimum GPA of 2.5 for all prior college work including transfer credits.

Options

In addition to the standard Anthropology course of study, two options are available in the Anthropology Major:

- 1. Medical Anthropology and Global Health (MAGH)
- 2. Anthropology of Globalization (AG).

Admission to either option is competitive. The application deadline is the second Friday of Autumn, Winter and Spring quarters. Applications will be available on the departmental website on the first day of the quarter. Transfer students must be admitted to the University before they can apply to the major.

In addition to meeting the requirements for admission to the Major, students who wish to apply in an option must complete additional application requirements available in the Anthropology advising office.

Note that meeting the minimum requirements for admission to the Major does not guarantee admission to either option. Students who apply for an option will be notified of the Departmental Review Committee's admissions decision by the end of week 5 of the quarter in which they apply. Anthropology students are not required to participate in an option; they may select to follow the standard course of study given below.

Major Requirements

The standard course of study for Anthrpology includes 55 credits as follows:

- 1. Core courses (20 credits): ARCHY 205, BIO A 201; any 200-level ANTH course; and one of the following: <u>CS&SS/SOC/STAT 221</u>, STAT 220, STAT 311, or Q SCI 381
- 2. 35 additional ANTH, ARCHY, and BIO A credits distributed across the subfields or concentrated as suits the interests of the student. 20 of these credits

must be in upper-division (300- or 400-level) courses. Students may count one 100-level ANTH, ARCHY, or BIO A course toward the major, but are not required to do so.

- a.The following AIS courses may apply toward this requirement: AIS 201, AIS 202, AIS 203, AIS 240, AIS 311, AIS 312, AIS 316, AIS 317, AIS 330, AIS 335, AIS 340, AIS 443.
- b.Maximum 12 credits (18 credits for departmental honors students) from ANTH 499, ARCHY 499, and BIO A 499 combined can be counted toward the major.
- c. For students enrolled in the MAGH or AG options, these additional requirements must be met:

Medical Anthropology and Global Health Option Requirements:
Completion of ANTH 215 and completion of 15 credits from ANTH and BIO A courses approved for the MAGH option (available in the Anthropology advising office, Denny Hall 243 or on the Department of Anthropology website).

Anthropology of Globalization Option Requirements:

Completion of 20 credits from courses in ANTH, ARCHY, and BIO A approved for the option (available in the Anthropology advising office, Denny Hall 243 or on the Department of Anthropology website).

- 3. Additional major requirements:
 - a. Courses with a grade of 1.9 or lower do not count toward the major.
- b. At least 25 credits in the major must be completed with a minimum grade of <u>2.5</u>.
- c. Transfer students must complete a minimum of 15 upper-division credits in Anthropology at the UW.

Continuation Policy for the Bachelor of Science degree program in the Department of Statistics

This document clarifies what constitutes satisfactory progress towards degree for undergraduate students in the Bachelor of Science degree program within the Department of Statistics. While the University has regulations governing scholastic eligibility for continuance¹, the Department of Statistics seeks additional requirements in order to make the best use of the limited facilities and resources available and to provide reasonable assurance for academic success. The following will apply to all students in the Bachelor of Science degree program in Statistics.

General Expectations of Satisfactory Progress:

- 1. Students are expected to make satisfactory progress towards the attainment of the degree. Under normal circumstances, an a Statistics major attending full-time would be considered making satisfactory progress if he/she completes all major prerequisites by the end of the Sophomore year (within 90 cumulative units) and completes the major requirements (core courses, major electives, and capstone) during Junior and Senior years. Lack of academic progress may be evidenced by low scholarship as well as excessive course repeats, course drops, or University withdrawals and cancellations.
- 2. Students must maintain a minimum cumulative GPA of 2.5 in major requirements, with a minimum grade of 2.0 or above in each Statistics class used to meet major requirements (e.g., core courses, major electives, and capstone). Courses used to satisfy major requirements cannot be taken on a satisfactory/non-satisfactory basis.
- 3. Students must maintain a minimum cumulative GPA of 2.0, and thereby avoid appearing on the University's Low Scholarship list².

Conditions Warranting Recommendation to Alter a Student's Standing:

The Statistics department will review the performance of undergraduate students after each quarter. If a student fails to meet the general expectations of satisfactory progress outlined above in any quarter in the program, the following actions will be invoked.

Students will be notified of probation or dismissal from the major as soon as practicable after review of the previous quarter's grade reports. Failure to meet one or more of the general expectations of satisfactory progress may also result in the following actions.

Probation for the Major

If at the end of any quarter, the student fails to meet the general expectations of satisfactory progress, the student will be placed on probation. Once on probation, the student must achieve a quarterly GPA higher than 2.50 in the following quarter. If any single grade for a course required for the major is below 2.0, the student is required to meet with an adviser to discuss any difficulties impacting

the student's academic performance and to resolve problems and develop an individualized educational plan to avoid dismissal from the major.

Dismissal from the Major

The student can not be on probation for two consecutive quarters and will be dismissed from the Statistics major if, while on probation, the student fails to meet the minimum cumulative GPA of 2.50 the following quarter, fails to achieve a minimum grade of a 2.5 in any repeated course required for the major (if the course was an elective a minimum grade of 2.5 in alternative elective is acceptable), or fails to meet one or more of the general expectations of satisfactory progress. The student will be notified in writing of the change in major status, and will re-coded as a pre-major or extended pre-major.

Appeal Procedures

A student who has been placed on probation or has been dismissed from the major and believes that some facts in the student's documentation have been overlooked or misinterpreted may request reconsideration of the probation or dismissal from the major by writing a letter to the department. Included in the letter should be any additional information in support of the student or any other information that the student believes is relevant. In general, appeals to alter the student's status without evidence of new or additional information will not be considered. The appeal must be made within 30 days of the notification of placement on probation or dismissal from the major and will receive a response from the Statistics department within 30 days from response of the student's appeal.

LAWRENCE DASHIELL TRUE

I support it - the program is timely and enhances strengths of UW, as well as having appeal to students, in my opinion

STEPHEN A. BEZRUCHKA

It would be good to have some global health content from the Department of Global Health. I might suggest GH 490 (cross-listed with Hserv 482), Population Health which would enhance the options.

This quarter the course has some 120 students, and requires them to take the course material and disseminate it.

MARY ANNE MERCER

This sounds like a very interesting set of options for undergraduates interested in anthropology. I am concerned however that the proliferation of global health programs do not seem to include the recommendation or even the option of on-the-ground experience in a health setting. I think that any student who claims 'global health' expertise should have some first-hand experience of the challenges of addressing health issues in resource-poor settings. I don't know that this is feasible for all students in this track but I strongl believe that it should be at least encouraged.

I also agree with the above comment that any Global Health Department courses that are available to undergraduates should be included as options for these students.

LINDA MURDOCK

It makes me wonder, from an administrative point of view, whether it's wise to have a competitive option in a non-competitive degree. Structurally, wouldn't it make more sense to offer two additional, competitive degree programs in addition to the BA currently offered, that isn't competitive? If you did this, you could restrict students from taking specific classes based on major code in the time schedule. Otherwise, what is to prevent a student from completing all of the degree requirements for the option without being admitted into the competitive option, then coming to the department after the fact and making the case to be granted a degree including the option that they were never admitted to? Seems like this needs to be discussed from this perspective.

CLAYTON C. SCHWENN

I think the new tracks within Anthropology recognize that Seattle and UW are at the nexus of global and public health. Resources have been marshalled, and UW students stand ready to be educated to enter this academic field. What I think Anthropology needs to reconsider is the "At least 25 credits in the major must be completed with a minimum grade of 3.0." requirement. This is unprecedented among the 150 other majors at UW, and current FCAS policy would not typically allow a department to propose this requirement. While I think it's fine that Anth moves from an open major to a minimum requirement major, I think the "25 credits in the major must be completed with a minimum grade of 3.0" needs to be eliminated, or brought in line with the other departments on campus (typically 2.5 major GPA).

JULIE A. BESCHTA

This is an impressive curriculum. As noted above, it might be worth considering including some of the undergraduate course offerings from the Dept. of Global Health, including the course listed above, as well as GH 415 (Global Health Challenges), and GH 101, Global Health: Disparities, Determinants, Policies, and Outcomes (to be offered winter 2011, pending university approval).
