EXPLANATION OF AND RATIONALE FOR PROPOSED CHANGE

The BASW Program Committee has been discussing changing the number of credits of the three clinical skills courses from 3 to 5 credits. This change would allow for more time in the classroom to practice the skills in groups. Also, the faculty believe that meeting twice/week instead of once/week will help the students to maintain momentum in their learning.

This 1503 only changes the number of credits for Soc Wf 310, 311 and 312 (course change applications submitted at the same time) and increases by 6 the total number of credits required for the degree – the credits being added through changing these courses.
