School of Social Work **BASW Departmental Honors Program**

Eligibility - To apply, students must:

- Have completed two quarters (Aut and Win) of their first year in the BASW Program
- Have a minimum of a 3.8 average gpa in their social welfare courses (Soc Wf) and an overall cumulative UW gpa of 3.3.
- Submission of a complete application by the deadline.

Information Session

An Honors Program Information Session would be held toward the beginning of spring quarter, describing the application and timeline, the full requirements of participation in the Honors Program, and how the latter is different from the standard capstone project. Examples of "ad hoc" honors projects could be presented during the information session.

Application Process (applications due May 20th)

An Honors Program Application would be required and would include:

- · why the applicant wants to engage in Honors;
- the research or inquiry area of interest/question;
- potential faculty mentor(s);
- faculty references (1-2).

Not all students meeting application eligibility requirements will be accepted. Admission is competitive. Criteria will include:

- Thoughtfulness and thoroughness of application
- Feasibility of project
- Likelihood of faculty support and mentorship
- Student academic maturity and ability to self-manage

Applicant Screening (done late spring quarter, completed by May 30th)

An accepted applicant would receive written, informative feedback about the strengths and limitations of the application and would be encouraged to continue the research process during the summer into the fall, such as securing a faculty mentor with whom the student defines a specific research project and bolstering the stated area of interest by conducting a literature review.

Non-accepted applicants would meet with someone on the screening committee who would give feedback on the strengths and weakness of the application, especially the reasons for non-acceptance at this time. The student would be reassured that the non-acceptance would not affect his/her good standing in the BASW Program. If appropriate, the student would receive suggestions on how to strengthen or revise the application with the intent of re-applying for Honors by September 25th.

Re-application (due September 25th)

Students may re-apply to the program, taking into account feedback given, by the September 25th deadline, and still begin the program with the Autumn cohort.

Coursework

Soc Wf 390 (H, 3 credits)

This course is already a required course for all Soc Wf majors. We would offer an honors section of this course that would meet concurrently with the non-honors section, but the honors section would have assignments with a more explicit focus on helping honors students to prepare their research proposals by the October 31st BASW Honors proposal deadline.

Soc Wf 491 (H, 3 credits)

This one credit seminar will be offered quarterly throughout the last year in the program and will generally meet every other week. In Autumn, the seminar will focus on guidance on proposal development, including a session on the human subjects review process. In winter and spring, the seminar will continue and focus on how the projects are going, problem-solving, peer and faculty feedback, and preparation of spring presentations.

Soc Wf 492-493 (H, 6 credits)

This six credit requirement (3 credits/quarter) is the Honors Thesis. It includes both a written paper and a presentation (oral or poster is allowed, but oral presentations will be strongly encouraged.) There will be specific standards developed for each type of research project and the paper will be reviewed by at least 2 faculty for feedback.

An additional honors course (H or ad hoc, 3-5 credits)

Chosen by the student. Students have the following options:

- Any 300 or 400 level Soc Wf course designated for honors credit OR ad hoc credit;
- Any Soc W 500 level graduate course (on a space available basis); or
- Any designated honors course/section offered at the UW; or
- A non-honors course from any department where the student has negotiated ad hoc honors credit, but it would typically be a course at the 300 level or above and/or provide the student the opportunity to engage with the content of the course at a deep level.

DARS programming:

- Soc Wf 390, 491, 492 and 493 would all count toward current BASW requirements (390 is already a specific degree requirement; 491, 492 and 493 would count as electives).
- Any Soc Wf (designated honors section/course OR ad hoc) at the 300 level or above or Soc W 500 level
 course taken as the additional honors course will be accepted as a BASW elective in addition to
 fulfilling the honors requirements.
- The additional honors course, if not meeting one of the criteria above, would not automatically count as a BASW elective, but the student could request it to be considered as such. The student would submit a petition requesting evaluation, and the criteria would be the course's relationship to the social welfare field or connection with the student's thesis project.
- The thesis presentation requirement will be embedded into the course requirements in 491, so will not be programmed as a standalone requirement in DARS.

Other notes:

Soc Wf students who do not submit successful proposals by the October deadline will:

- Be given direct verbal and written feedback so they might bring the proposal up to the level needed to be successful; or
- May be counseled to continue on with the project, but for Soc Wf 490 credit rather than honors credit; or
- The student may choose to not proceed with the project.

In either of the last two situations, the student may be switched into the non-honors section of Soc Wf 390 and may choose to drop the Soc Wf 491 seminar for Autumn quarter.

Soc Wf students who choose to not complete BASW honors will in no way be penalized. The completed honors courses will be used as BASW required and elective classes, with the exception of the outside honors course, which may be petitioned to count as an elective if it was taken outside the School of Social Work. (see DARS programming section.)
