EXPLANATION OF AND RATIONALE FOR PROPOSED CHANGE

In AUT 2014, the Public Health Major launches its new curriculum with four new Integrated Core courses. We are proposing that in addition to a minimum 2.0 cumulative GPA in those four courses - SPH 380, 381, 480, and 481 – that students earn no less than a 1.7 GPA in any of the individual courses prior to moving into their final Capstone. We have designed these courses around introduction, mastery, and development of program learning objectives mapped to accreditation criteria being developed for baccalaureate programs by the Council on Education for Public Health (CEPH). As our Major is a hallmark of our nationally ranked School of Public Health, and we ensure that our graduates are competent to carry out broad public health functions in multiple settings, it is necessary for us to require higher expectations in these integrated courses.

It is also necessary to update our Continuation Policy to align with previously approved changes to start in AUT 2014 and in light of this new request. We believe it is appropriate to use the Continuation Policy as a tool in reminding students of academic and professional standards and have edited language to reflect that goal.

The following criteria and procedures will be applied to determine continuation in the Public Health Major. Students are encouraged to review their academic progress and be proactive about seeking advice for problems affecting performance or participation in the program.

Basic Criteria for continuation applicable to all students in the Public Health Major:

- o Full-time students must complete 9 or more credit hours per academic quarter except summer that are applicable towards their degree(s).
- Part-time attendance is possible and students must complete at least one course each quarter that is applicable towards their degree(s).
- Students must earn a cumulative 2.0 GPA in courses applied to the major. public health foundation courses as well as the public health capstone.
- o Students must earn a minimum 1.7 in SPH 380, SPH 381, SPH 480, and SPH 481.
- o Students must earn a minimum 2.0 in Public Health Capstone (SPH 491-SPH 492).
- Courses used to satisfy degree requirements cannot be taken on a satisfactory/non-satisfactory basis.
- All students must maintain both an overall and public health GPA of at least 2.00. If either GPA falls below 2.00, the students will be placed on academic probation. Students cannot be on probation more than two consecutive quarters.
- O Students must take courses in the appropriate sequence. All prerequisites must be completed before registering for a course, unless permission is obtained from the instructor.
- Students must file a graduation application with the undergraduate program adviser(s) in accordance with University regulations, to ensure graduation once all requirements have been satisfied.
- o Students receiving satisfactory progress registration holds should immediately contact the undergraduate program adviser(s) to file a graduation application.

The program recognizes that exceptional circumstances (e.g. death in the family, serious illness) may delay degree progress. In addition, educational opportunities such as study abroad or internship opportunities may warrant the extension of a student's program.

Students who do not meet basic criteria for continuation in the Public Health Major will be first placed on School probation. Students on probation who do not meet minimum expectations by the end of the following quarter will be dropped from the major.

The undergraduate program adviser(s) monitors progress for undergraduate students each quarter and students will be notified of academic probation or drop by email as soon as practical after receiving the previous quarter's grade reports.

Students on probation are expected to meet with the undergraduate program adviser(s) to determine a plan for successful completion of program requirements which may include repeating or replacing a course. Students who meet expectations by the end of the quarter (longer if deemed necessary for courses taught only once a year) will be removed from probation.

Students must practice high standards of academic and professional honesty and integrity both on and off campus in compliance with the University's Student Conduct Code. Students found violating academic and professional standards will be subject to sanctions as outlined by the Community Standards & Student Conduct Office.

Appealing a Drop
