(Use additional pages if necessary). NHS, in partnership with UW Medical Center, Harborview, Swedish and Virginia Mason, will offer our RN-BSN degree program in Seattle. Faculty voted to support this change on November 7, 2012. Classes will be held at Harborview Medical Center. The Seattle area has the largest pool of Associate Degree nurses needing to obtain a Bachelor of Science degree in nursing. Most hospitals are seeking "Magnet Status" which requires that 80% of nurses have at least a Bachelor's degree. Our partner agencies will place our students in each other's (not their own) agencies for their Community Health (BNURS 409) requirement, thus avoiding any additional pressure on clinical placements in that area. 40 students will be enrolled in a four-quarter course of study. This is the same curriculum we offer at Bothell and Everett. Copies of Memorandum of Agreement are attached. Draft INTERAGENCY AGREEMENT BETWEEN UNIVERSITY OF WASHINGTON BOTHELL AND SWEDISH MEDICAL CENTER

This Agreement is entered into by and between University of Washington Bothell, hereinafter referred to as "UW Bothell", and Swedish Medical Center hereinafter referred to as "Swedish", pursuant to the authority granted by RCW 39.34.130 and through Chapter 179, Laws of 2006.

The purpose of this Agreement is to define the terms for UW Bothell's delivery of the program specified herein. UW Bothell agrees to provide instruction for <u>40 students</u> in academic year of 2014-15 in the facilities of HARBORVIEW, in the following program: **Bachelor of Science in Nursing.**

SECTION I: CONTRACT AND OPERATIONS MANAGEMENT

Operations and services provided for this program will be administered through UW Bothell. To that end, the parties agree specifically to the following:

Duration of Agreement

- The period of performance of this Agreement will be September 1, 2014 through August 31, 2015.
- 2. This Agreement is renewable upon mutual agreement of both parties. Any extension to this Agreement will be made in written form and signed by both parties.
- 3. Both institutions agree to review these terms and conditions by June 1, 2014 and hereafter by <u>January 15th</u> of each year during the duration of the Agreement.

- 4. Both institutions agree that if the Agreement is terminated, provisions will be made for students in the program at the time of termination to complete the program in a reasonable time period.
- B. Program and Services

UW Bothell will provide instruction for students enrolled in the Bachelor of Science in nursing program at the facilities of Harborview Medical Center from **September 2014** through **August 31**, **2015**. The 40 students will be employees of the four Seattle partners; Harborview, University of Washington Medical Center, Virginia Mason Medical Center and Swedish Medical Center.

- C. Student cohort size and composition
 - 1. The Seattle cohort will consist of 40 students.
 - 2. All of the 40 students will be RN employees of one of the Seattle Partners.
 - 3. Each Seattle partner will have reserved student slots for their employees as follows:

a. Harborview: 12 b. Swedish: 10 c. UWMC: 10 d. VMMC: 8

- 4. If one of the above partners does not fill their reserved slots UWB will determine allocation and/or assignment of unfilled reserved seats in consultation with the other partners.
- D. Seattle Partner Contributions and Payment:

Compensation paid to UW Bothell by Swedish for the work provided in accordance with the Terms of Agreement has been established under the terms of RCW 39.34.130.

 Each Seattle Partner will contribute \$8,750 per cohort, annually to support the additional expenses for this off-site program. Payments are due Oct. 31, 2014.

E. Student Tuition

UW Bothell will charge students in the Seattle cohort the regular academic year state tuition and fees.

F. Termination

Rights of termination shall be:

- 1. This Agreement may be terminated at the sole discretion of either institution prior to July 1, 2014 in the event funding support or organizational structures change substantively such that the Agreement is no longer beneficial to both institutions. Both institutions agree that if the Agreement is terminated, the terms of the termination will be confirmed in writing and provisions will be made for students in the program at the time of termination to complete the program in a reasonable time period. Nothing in this Agreement shall be construed to prohibit the parties to sign a new and superseding agreement, as changed conditions shall warrant.
- Mutual termination under this provision may be immediate or on a date certain if the parties
 agree and plans permit students completing the program in a reasonable time. Nothing in this
 Agreement shall be construed to prohibit the parties to sign a new and superseding
 agreement, as changed conditions shall warrant.
- 3. If for any cause, either party does not fulfill in a timely and proper manner its obligations under this Agreement, or if either party violates any of these terms and conditions, the aggrieved party will give the other party written notice of such failure or violation. The responsible party will be given the opportunity to correct the violation or failure within 30 working days. If failure or violation is not corrected, this Agreement may be terminated immediately by written notice of the aggrieved party to the other with the provision that students enrolled in the program at the time of termination have completed the program.

SECTION III: GOVERNANCE

A. No Guarantees:

It is understood that no guarantees, expressed or implied representations, promises or statements have been made by UW Bothell unless endorsed hereon in writing. And it is further understood that

this Agreement shall not be valid and binding unless same has been approved by UW Bothell, Swedish and approved as to form by the Office of the Attorney General.

B. Governance:

This Agreement is entered into, pursuant to, and under the authority granted by the laws of the State of Washington and any applicable federal laws. The provisions of this Agreement shall be construed to conform to those laws.

In the event of an inconsistency in the terms of this Agreement, or between its terms and any applicable statute or rule, the inconsistency shall be resolved by giving precedence in the following order:

- 1. Applicable state and federal statutes and rules;
- 2. Terms and Conditions as contained in this basic contract instrument;
- 3. Any other provision, term or material incorporated herein by reference or otherwise incorporated.

C. Assignment:

The work to be provided under this Agreement, and any claim arising there under, is not assignable or delegable by either party in whole or in part, without the express prior written consent of the other party, which consent shall not be unreasonably withheld.

D. Waiver:

A failure by either party to exercise its rights under this Agreement shall not preclude that party from subsequent exercise of such rights and shall not constitute a waiver of any other rights under this Agreement unless stated to be such in a writing signed by an authorized representative of the party and attached to the original Agreement.

E. ADA Compliance:

Both parties certify that they will comply with the Americans with Disabilities Act of 1990, as amended, with regard to programs, services, activities and employment practices.

F. Inability to Perform:

Notwithstanding any other provision hereof, in the event that either party is delayed in or unable to perform any act required under this Agreement and such delay or inability is due to causes beyond the reasonable control of either party, including but not limited to events such as strike, riots, martial law, civil commotion, war, fire, flood, earthquake, or other casualty or acts of God, the performance of such act shall be excused for the period of delay and the time period for performance shall be extended by the same number of days in the period of delay.

G. Severability:

If any provision of this Agreement or any provision of any document incorporated by reference shall be held invalid, such invalidity shall not affect, impair, or invalidate any other provisions of this Agreement which can be given effect without the invalid provision, if such remainder conforms to the requirements of applicable law and the fundamental purpose of this Agreement, and to this end the provisions of this Agreement are declared to be severable.

H. Entire Agreement:

This Agreement contains all the terms and conditions agreed upon by the parties. No other understandings, oral or otherwise, regarding the subject matter of this Agreement shall be deemed to exist or to bind any of the parties hereto.

i. Dispute Resolution:

In the event that a dispute arises under this Agreement, it shall be determined by a Dispute Board in the following manner: Each party to this Agreement shall appoint one member to the Dispute Board. The members so appointed shall jointly appoint an additional member to the Dispute Board. The Dispute Board shall review the facts, agreement terms and applicable statutes and rules and make a determination of the dispute. The determination of the Dispute Board shall be final and binding on the parties hereto.

 - 2. All of the 40 students will be RN employees of one of the Seattle Partners.
 - 3. Each Seattle partner will have reserved student slots for their employees as follows:

a. Harborview: 12 b. Swedish: 10 c. UWMC: 10 d. VMMC: 8

- If one of the above partners does not fill their reserved slots, UWB will determine allocation and/ or assignment of unfilled reserved seats.
- D. Seattle Partner Contributions and Payment

Compensation paid to UW Bothell by UWMC for the work provided in accordance with the Terms of Agreement has been established under the terms of RCW 39.34.130.

1. Each Seattle Partner will contribute \$8,750 per cohort annually to support the addition expenses for this off-site cohort. Payments are due Oct. 31, 2014.

E. Student Tuition

1. UW Bothell will charge students in the Seattle cohort the regular academic year state tuition and fees. (see addendum A)

F. Termination

Rights of termination shall be:

- 1. This Agreement may be terminated at the sole discretion of either institution prior to July 1, 2014 in the event funding support or organizational structures change substantively such that the Agreement is no longer beneficial to both institutions. Both institutions agree that if the Agreement is terminated, the terms of the termination will be confirmed in writing and provisions will be made for students in the program at the time of termination to complete the program in a reasonable time period. Nothing in this Agreement shall be construed to prohibit the parties to sign a new and superseding agreement, as changed conditions shall warrant.
- Mutual termination under this provision may be immediate or on a date certain if the parties agree. Nothing in this Agreement shall be construed to prohibit the parties to sign a new and superseding agreement, as changed conditions shall warrant.
- 3. If for any cause, either party does not fulfill in a timely and proper manner its obligations under this Agreement, or if either party violates any of these terms and conditions, the aggrieved party will give the other party written notice of such failure or violation. The responsible party will be given the opportunity to correct the violation or failure within 30 working days. If failure or violation is not corrected, this Agreement may be terminated immediately by written notice of the aggrieved party to the other with the provision that students enrolled in the program at the time of termination have completed the program.

SECTION V: GOVERNANCE

A. Assignment:

The work to be provided under this Agreement, and any claim arising there under, is not assignable or delegable by either party in whole or in part, without the express prior written consent of the other party, which consent shall not be unreasonably withheld.

B. Inability to Perform:

Notwithstanding any other provision hereof, in the event that either party is delayed in or unable to perform any act required under this Agreement and such delay or inability is due to causes beyond the reasonable control of either party, including but not limited to events such as strike, riots, martial law, civil commotion, war, fire, flood, earthquake, or other casualty or acts of God, the performance of such act shall be excused for the period of delay and the time period for performance shall be extended by the same number of days in the period of delay.

C. Severability:

If any provision of this Agreement or any provision of any document incorporated by reference shall be held invalid, such invalidity shall not affect, impair, or invalidate any other provisions of this Agreement which can be given effect without the invalid provision, if such remainder conforms to the requirements of applicable law and the fundamental purpose of this Agreement, and to this end the provisions of this Agreement are declared to be severable.

D. Agreement Changes, Modifications and Amendments:

This Agreement may be changed, modified, or amended by written agreement executed by both parties.

ADDENDUM A

Nursing Program Tuition Exemption Policy

Purpose of the Policy

In order to provide an option for students who are eligible for tuition exemption while containing the tuition waiver authority of the Nursing and Health Studies Program within a range that is tolerable with respect to fiscal constraints, enrollment, and available space, the University of Washington Bothell will not allow nursing students to register for courses administered by the UW Bothell Nursing and Health Studies Program (BNURS, BHLTH, and BHS) using tuition exemption with the exception of one BNURS undergraduate and one BNURS graduate course designated by the Program.

For those two courses, tuition exempt students will be enrolled on a space available basis only.

Scope

The Nursing Program Tuition Exemption policy provides guidelines regarding:	
 □ The use of tuition exemption; □ Allowable courses for which exemption may be used; □ Registration procedures associated with tuition exemption; and □ Identification of those who may gain access to the allowable courses. 	

Policy

1. Qualification for the use of tuition exemption

Authority is granted for The University of Washington Tuition Exemption Program under RCW 28B.15.558. This policy provides UW employees, other state employees and members of the Washington State National Guard the opportunity to have tuition waived for up to 6 credits per quarter on a "space available" basis. The policy further recognizes that certain courses may not be available under the Tuition Exemption Program such as UW Extension or distance learning courses, independent study, internships or any self-sustaining courses. In addition, the policy states that "...academic or fiscal considerations may exclude certain state-funded courses or programs from the Tuition Exemption program."

2. Allowable Nursing courses for which exemption may be used

A qualified nursing student may enroll on a space available basis in BNURS 350: Critical Thinking (4 credits) or BNURS 525: Leadership in Advanced Nursing (3 credits) using the Tuition Exemption program. All other courses in the UW Bothell Nursing and Health Studies Program are excluded from the Tuition Exemption program based on significant fiscal considerations and in order to maintain program viability and a full complement of course offerings.

3. Registration procedures associated with tuition exemption

In order to register using tuition exemption, students should carefully follow the steps identified in UW Bothell registration guidelines found at http://www.uwb.edu/students/registration/exempt.html. Questions regarding the procedure are to be directed to the University of Washington Bothell Registrar.

4. Identification of those who may gain access to the allowable courses

The courses for which tuition exempt students may enroll will be open to non-state employee students as well, accommodating tuition exemption students so long as space is available.

Memorandum of Understanding BETWEEN UNIVERSITY OF WASHINGTON BOTHELL AND HARBOVIEW MEDICAL CENTER

This Agreement is entered into by and between University of Washington Bothell, hereinafter referred to as "UW Bothell", and Harborview Medical Center, hereinafter referred to as "Harborview".

The purpose of this Agreement is to define the terms for UW Bothell's delivery of the program specified herein. Through the administration of UW Bothell, UW Bothell agrees to provide instruction for <u>40</u> students in academic year of 2014-15 in the facilities of HARBORVIEW, in the following program: **Bachelor of Science in Nursing.**

SECTION I: CONTRACT AND OPERATIONS MANAGEMENT

Operations and services provided for this program will be administered through UW Bothell. To that end, the parties agree specifically to the following:

Point of Contact

Though open and continuous communication among UW Bothell and Harborview is encouraged, both institutions agree to name a point of contact for the contracted academic program as well as for the operation and services provisions within this contract to provide a coordinated system for information-sharing, clarification, and inquiries regarding issues and/or services related to this collaborative partnership.

SECTION II: TERMS

- A. Duration of Agreement and Termination
 - The period of performance of this Agreement will be September 1, 2014 through August 31, 2015.

 - 3. Both institutions agree to review these terms and conditions by June 1, 2014 and hereafter by January 15 of each year during the duration of the Agreement.

B. Program and Services

UW Bothell will provide instruction for students enrolled in the Bachelor of Science in nursing program at Harborview facilities from **September 2014** through **August 31, 2015**. The 40 students will be employees of the four Seattle partners; Harborview, University of Washington Medical Center, Virginia Mason Medical Center and Swedish Medical Center.

 - 2. All of the 40 students will be RN employees of one of the Seattle Partners.
 - 3. Each Seattle partner will have reserved student slots for their employees as follows:
 - a. Harborview: 12 b. Swedish: 10 c. UWMC: 10 d. VMMC: 8
 - If one of the above partners does not fill their reserved slots, UWB will determine allocation and/ or assignment of unfilled reserved seats.
- D. Facilities

Harborview will provide:

- 1. classrooms and AV equipment/support for 40 students
- 2. computer labs for instructional coursework/support for 40 students
- 3. office space for advisor, and faculty
- 4. Faculty and staff access to printers, and tech support

Other services:

- Advising staff and faculty will be issued standard Harborview badges
- 2. Students will receive standard student badges from Harborview?
- 3. Students will receive new student orientation from Harborview staff
- 4. A copy center will be available for students, faculty and staff.
- 5. Parking passes?

No library services available onsite; students may access Health Sciences library for standard reserves.

E. Seattle Partner Contributions and Payment



Comment:

UW-Seattle School of Nursing (SON) has concerns that this program will increase competition for clinical sites and preceptors. UW-Seattle urges UW-Bothell in ensuring rigor in admission requirements for this option.

UWB Response:

We understand and empathize with concerns about competition for clinical sites and preceptors. We are not increasing the size of our program (and neither is EVCC—these students simply become part of their usual 40 student admissions).

As you can see in comparing the current and proposed catalogue content (see pages 15-16) the admission requirements for the BSN are identical. The UW Bothell Admissions department, the FYE Advisor and the UW Bothell BSN Curriculum Committee are carefully monitoring admissions and doing continual quality assessment to assure that the criteria and their application yields successful, high performing students. We have already revised the process based on lessons learned from the first cohort application process and will continue to do so. This is a very rigorous program and we (and our EVCC partners) are committed to enrolling and retaining talented students.
