The Liberal Studies Program proposes the creation of two minors for students not enrolled in Liberal Studies:

1. Liberal Studies: Comparative United States Studies

25 credits, to include

The Making of America (TLSUS 300) Four TLSUS or TLS courses

2. Liberal Studies: Comparative International Studies

25 credits, to include

International Interactions (TLSIN 300)
Four TLSIN or TLS courses

We believe these new minors will offer attractive options for students majoring in disciplines other than Liberal Studies at the University of Washington Tacoma, and that these minors will enhance such students' academic records. Students in Business Administration could, for example, put together courses in Asian studies to complement a focus in marketing, or courses in social work to enhance their management focus.

The Program is asking for the approval of this proposal by the Curriculum Committee as part of the process for implementation. After the Curriculum Committee reviews the proposal, it will be forwarded to the Joint Faculty Council, the Provost, and the President for their review and possible approval.
